



# Animal Adoption Center Foster Agreement

Thank you for participating in the Animal Adoption Center Foster Program. Once you have read the foster manual, please read and sign below. This is to ensure that you understand what is expected of, and what you can expect from the shelter. When completed, please return this signed form to the shelter.

Please initial below:

- \_\_\_\_\_ 1. I understand that the animal(s) I'm fostering are the property of Animal Adoption Center, and will abide by any decisions made by the shelter as to the return or disposition of the animal(s).
- \_\_\_\_\_ 2. I will return the foster animal(s) as scheduled, and transport them to AAC as needed for medical treatment or to meet potential adopters.
- \_\_\_\_\_ 3. I agree to abide by all AAC policies and procedures, including the procedures outlined and described in this manual.
- \_\_\_\_\_ 4. Since my companion animals are susceptible to any illnesses brought into my home by foster animals, I hereby certify that my own animals are current on their vaccinations.
- \_\_\_\_\_ 5. I understand that any treatment needed for my own companion animals is my responsibility, and I will not be reimbursed.
- \_\_\_\_\_ 6. A crate, food, litter, toys and necessary medications will be provided to me at no charge by the Animal Adoption Center, as long as they are available.
- \_\_\_\_\_ 7. If my foster animal is injured or becomes ill at night or on the weekend when the shelter is not open, I understand that I need to call the foster coordinator or shelter director immediately. If I take my foster animal to any other veterinary hospital or clinic without prior authorization, AAC will not be responsible for the costs incurred.
- \_\_\_\_\_ 8. If I can no longer keep the foster animal, I must contact the appropriate foster coordinator or the shelter director to make arrangements to return the animal.
- \_\_\_\_\_ 9. If I want to adopt the foster animal, I must notify the appropriate foster coordinator.
- \_\_\_\_\_ 10. All decisions made by AAC management are final.

*WHEREAS: I have expressed the desire to participate as a foster volunteer at the Animal Adoption Center, and WHEREAS: that request is deemed acceptable to the Animal Adoption Center, providing the undertaking is completely at the sole risk of myself to injury or death resulting from such undertaking, therefore I do hereby assume personally all risk of injury or death and hereby agree to hold safe and harmless and release forever the Animal Adoption Center, its employees, and Board of Trustees from all liability whatsoever to me, my heirs, or assigns. Such release of liability shall expressly cover all acts or occurrences of any kind in agreement thereto: I hereby execute this release and do release the Animal Adoption Center, its employees, and Board of Trustees and agree to hold them safe and harmless from any action arising from my participation as a foster volunteer.*
